## Croatia and Bosnia and Herzegovina Projects

The Grand Prior of Croatia informed the Grand Master that contacts had been made with the international organization whose LIONS. High Representative discussed with the Order projects that would be financed together, primarily for humanitarian work, especially with children, and plans for some projects that could be realized with international financial assistance in the field of the Templars in the Republic of Croatia and Bosnia and Herzegovina.

The projects, Slavonski Brod, Kiseljak, and Rijeka are being finalized. All three projects are very demanding. The Slavonski Brod Project is led by the Reverend Brothers Stipo Corluka and Zeliko Golubicic. The Kiseljak Project is led by OSMTJ BiH and headed by Antoni Beus, and Nikica Kucic heads the Rueka Project.

The Slavonski Brod project was conceived as a project to purchase real estate in the area of Slavonski Brod, on which a multifunctional facility would be built. In the first row, it would be a home for neglected children in that southern part of Slavonia, and the second part would serve the needs of our Order.

The Kiseljak project is a project to renovate the house and garden of the Franciscan Order,

which was leased from them for the needs of our Order, which would serve as a multicultural and interreligious place for the exchange of information and knowledge and interethnic dialogue of all peoples. It would also be the house where our Order would have headquarters in BiH and serve as a center of knowledge about our Order, which would include a library that was contractually left to use by Regent Nicolas Haimovici Hastier.

The Rijeka project is the planned renovation of the classroom of the secondary craft school.

All these projects, when finished in writing with all the necessary attachments, explanations, and legal basis, will be forwarded to LIONS for final approval for funding.

Another international agreement is a course for young people which, under the auspices of EU funds organized by our fraternal orders from the Baltics and Cyprus, allows our youth to stay to socialize with young people from across the EU.

Lastly, the project on the historical heritage of the Templars in the Republic of Croatia is led by Damian Golubicic, who will inform the Order about
